- dental or optical expenses unless incurred as the result of an emergency
- loss not reported to the police, transport carrier or other authority within 48 hours of discovery and a report obtained (Personal Property only)
- ski equipment if left unattended in place where the public have access or left in an unattended motor vehicle (Personal Property only)
- loss of Money from any unattended vehicle unless the Money was out of sight in a locked compartment (money only)
